**PRESENTATION**

All work must arrive completely assembled and ready to install. Frames must have screw eyes and a hanging wire attached to the back; textiles and fiber work, a suitable support or framework for hanging. Non-compliance may void the entry. No work may be substituted or withdrawn.

**DELIVERY/SHIPPING**

Hand-delivered artwork will be received Sunday, April 28<sup>th</sup> – 2:00 p.m. - 4:00 p.m. Artists must pay all expenses for shipping work to the exhibit. All shipped work must be received by Wednesday, April 24<sup>th</sup> 4:00 p.m. with a **prepaid return label enclosed** and in a reusable container with opening instructions and weight printed on the outside. Containers and/or artwork found to be damaged by the shipper will be returned COD after the artist has been notified.
